RESOLUTION NO. 20148

A RESOLUTION OF INTENTION TO ESTABLISH FEES TO BE CHARGED FOR THE LAST CHANCE SPLASH WATERPARK AND POOL

WHEREAS, the City of Helena operates the Last Chance Splash Waterpark and Pool facility, which includes the operation of a waterpark and concession building; and

WHEREAS, Resolution 19899 previously established user fees for the Last Chance Splash Waterpark and Pool; and

WHEREAS, there have been numerous requests from the public for private swim lessons to be offered at the Last Chance Splash Waterpark and Pool; and

WHEREAS, staff recommends that private swim lessons be added to program offerings at the Last Chance Splash Waterpark and Pool; and

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the Helena City Commission hold a public hearing on the proposed fees for private swim lessons.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. That it is the intention of the Helena City Commission to establish the following user fees for the Last Chance Splash Waterpark and Pool facility in Memorial Park:

Section 2. Punch passes are transferable and are valid for 10 visits per season. Unused punches on punch cards will not be extended to the next season. No refunds will be given for lost or stolen punch cards.

Section 3. Season passes are not transferable and are good for unlimited visits during one swim season. Lost season passes may be replaced with proof of purchase.

Section 4. When the facility must be closed due to weather or health issues, One Dollar (\$1.00) vouchers that can be used towards the price of a subsequent entry may be issued to those individuals who have paid to use the Last Chance Splash Waterpark and Pool facility and are present within the facility when it is closed due

to weather or health issues. These vouchers are valid only during the same swim season.

Section 5. The following definitions apply for purposes of this resolution only:

“Adult” is a person 13 to 64 years of age.

“Private Swim Lessons” are one participant and one instructor unless a participant’s sibling is of the same swimming ability or level. In that case, a private lesson for two participants is allowed and subject to any fees established in this resolution.

“Senior” is a person 65 years of age or older.

“Resident” is any person who resides within the city limits of the City of Helena.

“Non-resident” is any person who does not reside within the city limits of the City of Helena.

Section 6. It is the intention that Resolution 19899 be superseded.

Section 7. A public hearing on these proposed user fees for the Last Chance Splash Waterpark and Pool facility in Memorial Park shall be held before the Helena City Commission in its chambers at 316 North Park Avenue in Helena, Montana, on **the 23rd day of March, 2015, at 6:00 p.m.**
