Subject: Update on E-bikes

Presented at the City Commission Administrative Meeting on 08.04.2021:

The Helena Open Lands Management Plan Identifies specific goals and objectives for Recreation, one of those being to develop an e-bike policy for Helena Open Lands. Helena City code, ordinance and resolution is silent on e-bike use and does not contemplate or define e-bikes. In April, the Helena City Commission determined e-bikes should be defined as motorized and prohibited from use as noted in Helena City Code 7-12-3 C., or by land deed. This predominantly pertains to Helena Open Space Lands on Mount Helena and Mount Ascension. It does not prohibit use on city streets and sidewalks. Additionally, the Commission provided direction for City staff to engage in a broader discussion, to be completed by December, around commuting and e-bike use in the remaining portions of the City.

The City has launched a public engagement initiative related to e-bikes and private use e-scooters. The initiative does not include commercial e-scooters. The City is exploring the potential benefits and challenges that e-bikes and private use e-scooters pose. The goal of this information gathering campaign is to inform future decisions on appropriate locations and uses for e-bikes and e-scooters within the City. The City completed a public survey earlier this summer where we received more than 800 responses to questions about e-bike use and interest. Staff is currently reviewing those results and researching and analyze options and different alternatives.

The City also installed no-E-bike signs at all of our major and minor trailheads throughout our open lands system. This has brought about some questions from trail users, specifically on trails like Le Grande Cannon. This is a trail that comprises City right-of-way, County right-of-way, Helena Open Lands, some private lands, and is also used to access many open lands trailheads. Many of our open lands trails are complex in that they are made-up of different ownership, so it is difficult to parse different parts of different trails for purposes of defining them in terms of motorized or non-motorized for e-bike management.

The City will continue to follow the process laid out here:

Public Engagement & Analysis, April → June 2021
Development & Synthesis, July → August 2021
Public Comment, September 01 → September 30 2021
Review & Recommendation, October → November 2021
City Commission Presentation, December 2021
