

I am totally against the variance request and ask that you deny it.

Carroll College is asking for a variance from the Helena (City) Board of Adjustments to increase the heights of buildings from 60' to 110'. Specifically, they wish to install new stadium lighting at the athletic stadium. For your reference, the new light poles will be taller than all but St. Charles Hall. Taller than the chapel, the library and the administration building and the residence hall on Benton. In short, no pun intended, the poles will be the second tallest structure on campus.

This 110- foot height is an 8 or 9 story building. Do you see one of these in Helena?

If you view any part of the campus from your home, your work, or your daily travels, you will then see these light poles. Forever. Our views will be slashed. Forget the view from Centennial Park to the northwest. Playing golf. That view of Mt. Helena is gone. Climbing Mt. Helena. Ugh, that view will be changed. Maybe you prefer a bedtime of 8:30 PM. Written Comments Re Variance Request - New Stadium Lighting at Carroll College

We are writing to respectfully request that the City Planning Division disallow the request from Carroll College to construct new stadium lighting that exceeds the currently allowed building height of 60 feet.

This variance will adversely affect the important, irreplaceable viewshed that graces this wonderful campus, our historic community and the lovely area that surrounds us.

The towers themselves will detract from the appearance of our community. To drive along the highways of our State is to notice the distraction of dozens of towers and industrial structures that already diminish our scenery and the natural attractiveness of our environment. The premise of high towers emerging from the beautiful campus of Carroll College sadly remind me of the girder- built, steel structure that once disgraced the solemn Gettysburg Battlefield.

The unnatural pollution of a unique, wondrous night sky should also be considered in terms of high, bright lights.

Candy and I have lived within city blocks of the Carroll College Campus for more than 25 years, and we frequently traverse this special place. We treasure the beauty and dignified development that the campus provides to our area. We value the joyfulness of campus / community activities, especially those that fill our neighborhoods with exceptional students and thousands upon thousands of citizens who support these students and enjoy their home. Parking, foot traffic and joyful noise have not been a problem.

Today there are virtually no adverse consequences from the inherent campus bustle. New nighttime activities will add to a positive potential and almost certainly bring about additional community benefits. But we believe that these benefits

can be attained without harming the view or adding to light pollution. This is especially true in consideration of modern advancements in artificial lighting in terms of intensity, directionality and efficiency. We can do better than this plan. Please deny the current request and ask the college to reconsider.

I urge the Helena Board of Adjustments to reject the variance request by Carroll College to install lighting at Nelson Stadium. I believe the proposed installation would be both unsightly and unnecessary.

Unsightly: The prospect of 110-foot towers looming over an otherwise picturesque campus is not attractive. The towers would also intrude on the viewscape from several angles, even at a distance. When in use, the lights would be glaringly visible from several angles as well, an unwelcome form of light pollution.

Unnecessary: Although I used the phrase "when in use," it is unclear what use the lighting would serve. Carroll's football and soccer contests have historically been daytime events. During the several years that Carroll used Vigilante Stadium, which has lights, the games occurred in daylight.

Even if the Frontier Conference were to begin scheduling some evening games, it's hard to imagine lighting at Nelson Stadium being used more than half a dozen times a year. This seems a small benefit for a large variance.

For these reasons, I urge the Board to reject the variance request.

David Curd's letter to the IR on Dec 2 was a revelation. It provides details of the Nelson stadium upgrade: 110 feet high light poles to illuminate the playing field and artificial turf to replace a grass surface. In reading past articles by president John Cech on the college website and in the Helena IR, there are laudatory descriptions of the project, but details are lacking. Here are a few important ones.

Has Carroll College asked its faculty what the impact of the lights on Dark Skies will be? For students taking astronomy and related physics classes, it is apt to have a very negative effect. For Helena homeowners who enjoy amateur astronomy, the meteor showers, occasional northern lights, or a clear view of our Milky Way galaxy, it will certainly be a disturbing negative.

Has the administration gone online to research the injury rates on the different field surfaces? Are they aware that The NFL players association and the USA World Cup women's team have lobbied for years to require grass on all fields because they feel certain that injuries are more common on artificial "turf?" The USA World Cup men's soccer teams have always had grass surfaces. But notably, The women's' World Cup have not until recently. The international soccer governing body FIFA finally relented in view of the players' demands. Future World Cups and international competitions for men and women will all be on grass. The college has not commented on these important issues in their publicly available proposals. They have an obligation to do so.

To Whom it May Concern:

I am writing in **opposition** to the proposed variance request to increase the maximum building height from 60' to 110' for the new stadium lighting at Carroll College.

As a single, working mother, I will be unable to attend the public hearing on December 5<sup>th</sup>, so I am providing my thoughts via e-mail.

For starters, **Carroll College isn't in a good position** to be requesting anything from community members at this point. Just within the last year, the college has shown an astounding lack of judgment:

1. Selfishly requesting ARPA funds for this same stadium enhancement project. It should be noted that eligible uses of ARPA funds include: public sector revenue replacement, COVID-19 public health expenditures, economic support for households and small businesses, premium pay for essential workers, and investments in water/sewer/broadband infrastructure. A stadium enhancement project DOES NOT meet any of these requirements.
2. Selfishly bulldozing homes at the corner of Benton and Lyndale Avenues, during a housing crisis, and choosing to replace the homes with water-intensive grass sod rather than badly needed housing.

Then, let's observe the **lack of communication** in regard to this project.

1. Very few community members were notified by mail (approximately 60 property owners). And this mail notice was received less than two weeks prior to the public hearing.
2. There was no press release or any other notification to the community about this variance request (aside from a fine print legal notice, and who reads those?).
3. This might explain why, as of Monday, November 27, 2023, no public comments had been received.
4. When community members were recently notified, by word of mouth, the overwhelming consensus was one of opposition to the lighting project.
5. In summary, had Carroll College and the City of Helena bothered to educate the public about the variance request, residents might have had more time to participate in the decision-making process.

Next, let's observe **the variance application** submitted by CWG Architects on behalf of Carroll College. The direct link to the application submission is [here](#). I am completely untrained in matters of zoning and ordinances, but I found several errors and misrepresentations in the application that gave me pause.

1. On page 2 of the variance application form, it states that the current maximum height is 65', when in fact it is 60'.
2. In the freeform attachment directly following the application, page 2, #3 ("Whether there is a prevalence..."), it states that the peak of All Saints Chapel is 4,190' above sea level. This is incorrect and should be noted as 4,090'.
3. In the same freeform attachment, page 3, #8 ("Provide any additional..."), it states that FAA approval was obtained back in 2011. That was 12 years ago. Presumably FAA requirements have changed since then. I would think CWG would do their due diligence and request an updated FAA approval, rather than relying on an outdated one.
4. The reasoning CWG uses to support the lighting request is invalid. CWG states that the height at the peak of All Saints Chapel would equal the height of the lights, so therefore, the height of the lights would be in line with existing structures. But the base of All Saints Chapel is near the top of a hill! The actual height of the chapel is only 50'. So there is really no comparison. Not to mention, the chapel is a much more beautiful structure than a light pole.
5. CWG also states that the peak of St. Charles Hall is 50' higher than the proposed lights, so therefore the height of the lights should be approved. The Hall is over 100 years old, presumably older than today's zoning restrictions, and it also sits ON THE TOP OF A HILL. It's a beautiful old building, unimposing, and it doesn't emit a harsh light. So, again, there's really no comparison.
6. Due to these rather obvious oversights, I am not inspired with confidence that CWG Architects is handling this project appropriately and fairly.

Next, let's refute **Carroll College's claims** that these lights are necessary.

1. The stadium has been unlit for over 20 years, and the Saints have managed to keep playing all this time.
2. Most spectators (and players) probably prefer sunny, mid-day games during the colder months, when nighttime games would be quite frigid. Day-time games give travelers the chance to get home safely at night. Night-time games necessitate either a late-night drive home or a costly hotel stay. Neither of which is in the best interests of the spectators and players.
3. Nearby residents already get enough light pollution from the lights at the Batch softball fields. I doubt folks are going to enjoy even more and even brighter lights from the stadium, with plans of them being used up to 75 nights per year.
4. The light poles will be ugly. Helenans tend to enjoy their views of the mountains. Folks exercising in Centennial park will see their view to the west obscured by light poles. Folks in the vicinity of Bill Roberts golf course and Nature Park will no longer be able to enjoy their full view of Mount Helena.
5. The proposed height of the stadium lights, 110', is equivalent to a 9-story building. Where in Helena have you seen a 9-story building? And would you like to see one?
6. The lights will be bright. They may not shut off until after 11 pm or midnight, depending on the type of event being hosted. In order for neighbors (and even college students in their dorms) to sleep at night, we will have to purchase blackout shades and eye masks. Sounds fun!
7. Most stadiums have their lights mounted at around 60'. Carroll College whines on their website that "other schools in town have lighting appropriate to their needs", but these other schools have light poles that are much lower and are also used less frequently than proposed by the stadium enhancement project (10 nights per year versus 75 nights per year).
8. Lastly, Carroll College isn't set apart from the town like many other college campuses are. Carroll College is located right in the middle of Helena. If it was set apart from the town, I could almost agree with the need for lights, because they would affect fewer people.

Finally, let's see how the project could **impact the community** if completed as proposed.

1. [Carroll College is proposing](#) holding up to **75 events annually** at Nelson Stadium, with possible attendance of 10,000 or more at each event. Logistically, there is **not enough parking** for these types of events. Carroll College doesn't even have enough parking for their home football games. And don't even think about driving down Benton Avenue on the day of the summer Symphony Under the Stars. During these existing events, people are

force to park very far away, or they end up parking illegally along the railroad tracks, along pedestrian trails, or in someone else's driveway. I am quite sure nearby residents will not appreciate having to put up with 75 such events annually. Not only will parking be an issue, but traffic in general will slow to a snail's pace as spectators arrive to or leave from an event.

2. If this variance is approved, Carroll College can build anything else they want up to 110'. They could erect a 9-story building. How would this look on campus?
3. **Competition with the Fairgrounds.** In June 2004, Lewis and Clark County voters supported a 10-year mill levy to construct the new grandstand and outdoor performance arena. We have already helped to pay for the Fairgrounds to be used as an event venue. Now Carroll College is saying they can do better. What happens to the grandstand that we all paid for if Carroll College siphons all large events to their Nelson Stadium? Also to note: the Fairgrounds already has plenty of available parking!

**One last fun fact:** How is it that the peak of Nelson Stadium is currently taller than allowed by the existing ordinance? The peak is 61'6". The current height limitation is 60'. How did Carroll College get away with that?

Finally, according to Section 11-5-5 of the Helena Zoning Ordinance, the **Board of Adjustment must consider the following standards** when reviewing a requested variance:

1. The variance will not create a significant risk to the public health, safety, or general welfare;
2. The variance will not significantly reduce or impair the peaceful use of existing property or improvements in the vicinity and the zoning district in which the subject property is located; and
3. Strict compliance with the provisions of this title would create unnecessary hardship or practical difficulty.

There are the **additional factors** that the Board of Adjustment may consider:

1. Special conditions and circumstances that are unique to the applicant's site, including the size of the property, unusual or extreme topography, or unusual shape of the property.
2. The height, location, or dimensions of existing structures located on the site or in the vicinity of the site.
3. Whether there is a prevalence of nonconformities in the vicinity of the site that are similar to the variance requested.
4. The subsequent imposition of zoning restrictions creating nonconforming lots or parcels, and governmental actions beyond the applicant's control.
5. Whether a literal interpretation of the provisions of this Title would deprive the property owner of rights commonly enjoyed by other properties similarly situated in the same district under the terms of this Title.
6. The extent to which the hardship or difficulty results from the actions of the applicant.
7. Whether granting the variance requested will confer an unreasonable special privilege to the subject property that is not available to other properties similarly located in the same zoning district.

If the Board considers these questions fully, beyond the scope of the answers CWG provided in their application, I believe the Board will agree to **oppose the variance**.

To Whom It May Concern:

I was appointed by Mayor Colleen McCarthy and served on the Helena Lighting Ordinance committee and was largely responsible for initiating the process to develop and implement a light ordinance for Helena. The reasons to try and preserve Helena's dwindling "dark sky" are many, from light trespass to allowing present and future generations to enjoy the wonders of the night sky, the constellations, and to diminish the harmful effects of municipal lights on wildlife, primarily migrating birds such as geese.

The ordinance grandfathered in the lights for the cathedral and Capitol, but put significant sidebars on other light sources, particularly billboards with upward pointing lights and flashing advertising displays.

The variance sought by Carroll College for its proposed lighting for the football field will simply make a laughing stock out of the ordinance and leave Helenans with even less of a real "night sky" than we have now -- and thanks to continued growth, it's already significantly diminished from what it was when we passed the lighting ordinance all those years ago.

The simple truth is the Carroll lights will serve only a very tiny portion of Helena's population while impacting the vast majority of residents subjected to its "eye in the sky" glare due to the extreme height of over 100 vertical feet.

Please record this email as strong opposition to issuing the variance.

Carroll is a small Catholic college, not some major university, and the last thing we need is more very bright lights in Helena for any reason, let alone football games, etc., at night. There is no proven "economic benefit" as lauded by the college and even if there was some slight advantage to having an even more brightly lit field, the impacts far, far outweigh the benefits.

The City -- and its government -- is charged to do the greatest good for the greatest number -- not to hand out variances to small special interests that impact "the greatest number" of its residents.

Dear City Commissioner and City Planners:

I am concerned about the variance application of Carroll College. The application is for the height of the poles, as though there is no issue about the lighting that will then be installed upon them. I think Carroll would need a variance for the lights themselves. I am concerned about both.

There are three issues related to outdoor sports lighting - spill light, glare and sky glow. Spill light is the light that trespasses onto adjacent property. Even more significant is glare, the excessively bright light that reduces your ability to see. This extends far beyond the adjacent neighborhood of Benton Avenue, and will effect a broad swath of Helena. And lastly sky glow, the light that overflows into the sky above the horizon.

Our community values dark skies, as is obvious from this document:

Our current city code reflects this:

LIGHTING GENERALLY, 10-1-1: PURPOSE AND INTENT:

It is the purpose and intent of this title to encourage lighting practices and systems which will minimize light pollution, glare, and light trespass; conserve energy and resources while maintaining nighttime safety, utility, and security; and reverse the degradation of the nighttime visual environment. It is recognized that the topography, atmospheric conditions, and nature of the city are unique and valuable to the community. The city, through the provisions contained in this title, promotes the reduction of light pollution that interferes with enjoyment of the night sky. (Ord. 2889, 1-24-2000)

Perhaps Carroll considers itself exempt from City Code, 10-2-6: EXEMPTIONS:

D Public Recreational Lighting: Public recreational lighting. (Ord. 2889, 1-24-2000)

However Carroll College, is a private, not public, institution, and does not qualify for this exemption. There was a recent reconfiguration of Vigilante Stadium lighting. It differed from Carroll's proposal in significant ways. It was a redo of existing lighting, not a new installation. More significantly, it was on public school property, exempt under 10-2-6:D. It appears that there was no variance requested or received for the Vigilante project...

Carroll's proposal is largely unknown within Helena. Many people no longer subscribe to the IR or watch the local news. I ask that there be an opportunity for the Helena citizens to discuss this project before this variance is granted. Without a community conversation, it will feel like the city staff and commission is not being responsive or respectful to Helena citizens.



Please accept this as a letter of support for Carroll College as they seek a variance to bring both artificial turf and lights to Nelson Stadium located on their campus. In full disclosure, I am a graduate of Carroll and played football for the school back in the 80's at Vigilante Stadium. I currently serve as the Activities Director for Helena Schools, but I am writing this letter of support not as a representative of the school district but as a supporter of Carroll. I am able offer my direct knowledge of the impact of lights at a stadium during football games in a residential neighborhood. I host a minimum of ten and as many as thirteen home football games on Friday nights at Vigilante Stadium. Each of those games played under lights from August to November each year. We have also needed to turn on the lights to complete early season track meets in April.

During our football season, our lights are on for roughly three to five hours each Friday depending upon the month and onset of darkness. Today's modern stadium lighting systems allow us to turn the lights down to 20% output as soon as our games end, dramatically reducing the ambient light in the neighborhood as soon as the game is completed, and the cleanup process begins. Our modern LED lights were designed to put maximum lighting on the playing surface with as minimal overshoot to the neighborhood as possible. If you have been to Vigilante Stadium, you know that our facility rests squarely in a residential neighborhood. We do not have hundreds of feet of separation from our light poles to surrounding homes, literally, two of our light poles sit across the street from houses. I bring this all up because in the three seasons we have had our newly designed lighting system I have had one complaint from a neighbor about the lights during a game. I have had several calls from neighbors regarding the lights turning themselves on when no event was taking place but that was traced to a software issue that we resolved by turning off all power to each pole at the end of the event guaranteeing the lights have no power and cannot turn on until power is restored.

I feel the need to address a potential conflict others may feel I may have that would cause my opinion to be distorted and self-serving. I am sure many will feel there is an agreement to have our high school games played at Nelson Stadium. The simple fact is that no such agreement exists. Yess, the school district has been asked if we would be interested in using Nelson as a site for our own home football games. But that decision has not been made and there have only been limited discussions about that happening. We have a football field; no one in the school district, me, our superintendent, or our head coaches are looking to leave Vigilante Stadium, the district's home football field for over fifty years. The only way a move of that nature would occur is after many meetings, a solid MOU and our districts stakeholder being convinced it is the best move for our students and district. My letter of support is in no way tied to such a move for the school district. This letter is simply written out of my personal support for Carroll and trying to share information with you regarding the impact of lights on a residential neighborhood that I have experienced as I carry out my duties hosting events, outdoors, under lights.

I believe the Nelson Stadium project currently being discussed is a step forward for both the College and our community as well. The opportunity for a modern, lighted, outdoor stadium in Helena is exciting for the college and I believe should be exciting for our community. I encourage you to gather information about the requested variance. Find out for yourself how these new modern stadium light systems are designed and work to focus light down to the playing surface rather than out to the neighborhood.
