### Helena Business Improvement District Hosts Public Meeting on Downtown Public Restroom Installation

[Helena, MT]- The Helena Business Improvement District (HBID) will hold a Public Meeting regarding the installation of a downtown public restroom. The meeting will use an Open House style format, providing an opportunity for the community to engage in an open dialogue about this necessary addition to downtown Helena.

Date: April 23rd 2024

Time: 4:00 PM - 6:00 PM

Location: HBID Office, 330 N. Jackson, Helena, MT

During the Open House, the public will be able to review the proposed location for the public restroom and to examine the type of restroom being considered. Community members are encouraged to ask questions and provide feedback on the project.

Since April 2023, HBID has diligently explored the installation of a downtown public restroom, prompted by increased use of the walking mall and greater attendance at downtown events. Part of this preliminary trial process was to place a portable toilet in Constitution Park in April 2023, where it remains and is open to use. The result was overwhelmingly positive.

"The BID recognizes the need and benefit of a public restroom to address increased commerce and tourism in the downtown business district and the popularity of the walking mall for public events," noted Seth Brandenberg, HBID Board Chair.

"We've done the research, have secured almost all of the funding, and we are hopeful we will see this improvement to downtown Helena take shape," stated Megan Helton, HBID Interim Director. The City of Helena has committed \$98,000 to the project, while Lewis and Clark County have pledged \$35,000. HBID will contribute \$44,000, with the total cost for the project estimated at \$240,000. Once the project goes through the public process, HBID will pursue additional funding sources. In the long term, HBID will be responsible for managing the installation, repairs, maintenance, and supplies.

The HBID represents property owners within Helena's legally constituted city district, and funding for HBID programs and services is derived from a special assessment on the district's property owners' tax bills. The organization serves as a vital catalyst for economic development in downtown Helena, sharing a vision and voice for the downtown community.



• Any potential victims of crime can be heard from the outside. • Blue interior lights make finding a vein for intravenous drug

• Fully ADA compliant – this is rare in downtown Helena. • Room for a stroller or bicycle.

It will more than likely have to be locked throughout the winter. This style of restroom the actual season usage will probably be at most 6 months of the year to prevent it from freezing. Just a few thoughts that I wanted to share to make sure it is a wise use of funds.
