As a longtime Helena resident and a multiple homeowner on North Jackson Street, I and other tax paying neighbors are against the Emergency Shelter Proposal in our zoning district. This isn't the place or a good location for a temporary or a permanent shelter to house individual's male or female. We have had many problems with the current homeless situation in our area, these include numerous break-ins, thefts, vandalism, people going through our dumpsters for discarded mail, random camping out wherever they please, using anywhere to go to the bathroom day or night, discarded trash & shopping carts, junk vehicles parked for long period of times, discarded drug paraphernalia, liquor bottles & cans, and cigarettes & other smoking paraphernalia. There also have been numerous calls to local Law Enforcement.

Watching the local news lately it seems like this proposal is already a done deal. I hope this isn't the case. Downtown Helena has a major problem daily with people sleeping and congregating in our parks and setting up camp wherever they please and starting fires and doing whatever they please. In the barbershop, I have had to replace the picture window and the window in the entry door, which were broken due to vandalism. My tenant, the barber, has had many problems with transients using the doorway to his business as a shelter, so customers couldn't access his business, In the alley behind where my business was accessed on the lower level of my building, I witnessed fights, drunkenness, urination, litter and fires. Sometimes I had to call the Police to deal with it.

It is TIME for the city of Helena to acknowledge and invest in the businesses and property owners who are the lifeblood of our city, and stop these "feel good" projects which are at the expense of business owners. The reason for zoning is to alleviate problems which this conditional use permit will inevitably cause.

For more than 10 years various community organizations have considered effective ways to address the needs of our unsheltered neighbors during Helena's bitter cold winters. We recognize and thank the Helena City Commission for the essential funds to help address emergency shelter for our most vulnerable neighbors. Representing the Outreach and Social Justice Committee at Plymouth Church we endorse Good Samaritan Ministries' proposal to shelter women in the downtown area, adjacent to their highly impactful day center, "Our Place."

Plymouth Church is one of many local non-profits and social service agencies to recognize the housing crisis and to offer assistance as best we can. Our congregation provides meals and food to God's Love; instigated the book read and fall 2023 discussion surrounding "Rough Sleepers", a Boston journalist's experiences with the unhoused; received significant funding for and design of a traveling photo exhibit titled "Faces of Our Unsheltered Neighbors" which features 10 of our Helena-area unhoused men, women and families and is currently booked through May of 2024; instigated a drive to purchase 50 sleeping bags for those living on the streets (which surprisingly raised enough to purchase another 50); organized a consortia of Clergy Advocates representing a variety of faith communities that are committed to addressing the housing crisis in Helena.

We attended most of the "Move the Dial" meetings orchestrated by United Way, attended the Emergency Housing Task Force and City Commission meetings when possible so that we might be better informed and responsive to specific needs. In all our work we are most grateful for the tutelage of Dr. Jeff Buscher of United Way and Theresa Ortega of Good Samaritan Ministries who have made us aware of acute needs and reasonable solutions to the housing crisis.

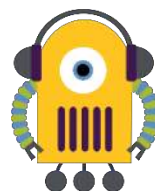

To Whom it May Concern,

This letter is to offer complete and full support for Good Samaritan Ministries' project to open a homeless shelter for women. This shelter will meet an important need for many women and their families in our community who currently have no stable or safe place to sleep at night, especially in the winter.

The mission of The Friendship Center (TFC) is to be a safe haven for those affected by domestic violence, sexual assault, and stalking (DVSA) and to empower our community to flourish in relationships free from violence. Trauma and violence often intersect with homelessness; homelessness can be a direct result of the trauma and violence someone has experienced, and being homeless dramatically increases the risk of experiencing trauma and violence. The two issues are so intertwined that it can be hard to distinguish and separate. Projects that will assist with the sheltering and housing crisis more broadly will by default benefit our clients (and community) because of the clear intersection of the issues.

The lack of available, affordable, and sustainable housing is a critical issue. The current sheltering agencies in our community are nearly always at capacity and/or have a waitlist. Additionally, only two agencies provide emergency shelter, which are not able to meet the needs of the community or, depending on the circumstances, safely meet the needs of women and their families. Currently, there is no shelter specifically for homeless women and their families in the tri-county area. Good Samaritan Ministries' shelter will offer our clients, as well as many others, a safe place to sleep while they figure out next steps – helping to meet the pervasive crisis we are all facing.

People should not have to win the timing lottery or sacrifice safety to have a safe place to sleep at night. It is necessary to have another shelter option in our community.

Good Samaritan Ministries' project to open a homeless shelter for women will fill a dangerous and large gap that has existed in our community for too many years. TFC offers unequivocal support for the project. We are committed to partnering with Good Samaritan Ministries to provide support to all DVSA victims that are sheltered through this project. We implore you to add your support for this project as well.

Ray and Susie Kuntz are against granting a conditional use permit for emergency shelter use at 648 Jackson Street in downtown Helena. We offer the reasons why we oppose this location, and offer potential solutions.

We are sympathetic of the growing homeless problem and the need to find solutions, but think having a homeless shelter in the middle of a growth area in downtown is a bad idea that will discourage any further development of the downtown area. We own property surrounding the proposed emergency shelter site including 803 and 807 Jackson Street, and have had growing theft problems as the homeless population has grown in the area. Granting the conditional use permit would clearly devalue our property.

We developed and maintain 50% ownership of the commercial property across the street – The Seeley Building. This building's 2021 construction is the direct result of the city's plan to revitalize downtown Helena. The building sits on the site of a formerly abandoned bus stop, and it has dramatically improved the look and feel of the downtown. This building has served as a catalyst for nearby improvements of other structures. We invested over \$18 million under the existing zoning. While plans sometimes change, the City should appreciate the negative impact this permit will have on its plans of downtown revitalization. Granting a conditional in this location is unfair to those who believed in the City's plans and invested in it. This homeless site will reduce the value of this building and leave any potential investor to walk away from plans with the City. Already today in the Seeley Building, we have employees afraid to park outside the building because of the homeless.

We also own commercial property on 320 Jackson Street and an apartment at 308 Jackson Street, near the existing God's Love shelter. In this area we have recurrent vandalism, trash accumulation, barbed wire cut on the roof and homeless trying to live in the front well and on the roof of the building, forcing us to invest in gates and additional locks.

We are in support of the proposal to develop the St John's hospital building into a homeless center. It is large enough to house the current needs of homeless.

For the immediate problem of this Winter, we recommend setting up one of the buildings at the Fairgrounds as an emergency center. It can be done quickly and offer a solution until late Spring. It is large enough to house the current needs immediately (and perhaps while the St John's facility is renovated).

I appreciate being able to write this letter of support for your work at Good Samaritan Ministries as part their strong application for a Department of Commerce, Emergency Shelter Funding Grant. (ESFG). This grant will fund Good Samaritan's Emergency low barrier Warming Shelter with trauma-informed care for the whole person. Good Samaritan Ministries operates "Our Place Day Center" where they provide addiction services, mental health support, housing navigation, assistance gaining identification, and more. These services, provided in part through meaningful community partnerships, will be an integral part of the programming offered to residents of this emergency shelter. I am confident in Good Samaritan Ministries' ability to expand upon their portfolio of meaningful assistance to our Helena community.

The Steward is helping gather volunteers for the effort to open in January 2024, and are continuing on our own effort to build and site Extreme Weather Emergency Shelters for that portion of our unhoused neighbors who may still be caught out side and exposed during "Code

Blue” (temperatures including wind chill expected to fall below 32 degrees F) and “Code Red” (temperatures expected to rise above 95 degrees F) periods.

Our 23 year old Montana non/profit fully supports the Good Samaritan Ministries’ candidacy for a ESFG grant. The needs of the unsheltered are complex, but this project stands to bring together a breadth of collaborating agencies whose work can be transformed when those they work with are sheltered. The Steward stands in a broad cross section of our community determined to make a path to recovery, realignment, and restoration a true prospect in our community. 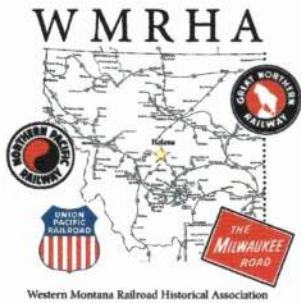

This letter is in response to your announcement of a proposed land use change for 648 Jackson St., Helena.

Our non-profit organization is a tenant at an adjacent property (619 N Last Chance Gulch) and we have concerns regarding the proposed change. Due to the short time frame associated with the announcement, we were not able to discuss this issue during our regular monthly business meetings and thus this letter may not include a full list of our Association's concerns.

While we recognize that homelessness is a serious and growing issue in Helena that needs to be addressed by the city, we would hope that the city understands the potential negative impact that the homeless population has on visitation and business potential in the historic downtown. As an organization involved with preserving and showcasing railroad history for western Montana, we have visitors from all over the U.S. that stop by our facility. For some visitors we are their primary destination when coming to Helena. The existing homeless population in our vicinity has already given many of our visitors cause for concern. Potentially facilitating even more homeless concentrations in what should be the most vibrant and visited part of the city doesn't seem to be in keeping with the many downtown improvement studies or our desires for a safe and attractive area as a downtown tenant.

Treating the homeless in a compassionate and respectful way is certainly the goal but focusing their population in the most tourist attractive part of the city doesn't seem like a reasonable or rationale thing to do. Thank you for your time.

Dear Zoning Commission and City Commission Members:

1. We need to help the unsheltered and those on the verge of losing shelter.

I believe that people must be willing to take care of themselves to the best of their physical and mental abilities. But I am also aware that is not always possible.

It is society's responsibility to help those who through no fault of their own cannot function as healthy individuals.

2. Concerns for Low Barrier population

The proposed shelter will be a "low barrier" shelter aimed at those who have mental illness or substance abuse. This is the portion of the unsheltered population that may be least likely to be willing or able to take care of themselves. It is also a population that is more likely to break the law simply by using illegal substances and illegally obtaining funds to purchase those substances. It is also a population that is more likely to be violent. My brother was that person, stealing from our mother, abusing medication, bruising his wife, threatening my sister and her husband. He destroyed the rental where he lived, went missing, and ended up in the psychiatric ward of a VA hospital.

3. Existing Need – Future Need

There is nothing in the application materials to substantiate an existing need for 26 emergency beds for women in the "low barrier" category. I do not doubt, however, that if there is insufficient existing need, the beds would soon be filled due to the growing influx of low barrier persons into Helena.

4. Safety - Generally

I live a few blocks from the proposed shelter. In the past 10 years, I have seen Helena work hard to make the downtown a vibrant place that attracts city residents and tourists. And it has indeed become a more lively place. But I fear that will be changing as I feel less safe downtown than I did five years ago. Tourists and residents are not going to come downtown when they are concerned about their safety. The increasing numbers of unsheltered who create unsanitary conditions, build fires, scatter trash and act erratically, agitated, and intoxicated or worse, is sad because clearly they need help. It's also frightening people away.

5. Where will Shelter Residents be between 9am-4pm?

I am absolutely concerned about the proposed shelter. The application indicates that there will be indoor places for the residents to go between 9am and 4pm, but our experience as neighbors is that they spill into surrounding areas, parks, alleys. God's Love is not open all day long, only certain times of the day. Do the services that are mentioned in the application have the capacity for the additional folks that will be in the shelter as well as others that may follow them into Helena? And, there will be shelter residents who do not want to be in any day-time facility that prohibits certain behaviors or activity. Instead they will be outside by their own choice, congregating with others who share that choice.

6. Shelter Residents who are Non-Compliant

Where will residents go if they are no longer allowed in the shelter if they are violent in the shelter or have a weapon? These violent and/or weapon-carrying individuals will add to the growing number of persons who have no shelter in our town, and likely within close proximity to the families in my neighborhood.

7. Effects on Downtown and Surrounding Areas

When downtowns begin to change in a way that results in fewer pedestrians and a feeling of safety at any time of the day or night, businesses and residents begin to leave. This is what causes decay and ultimately what caused so many downtowns to decline in the 1950s and ultimately resulted in the nationwide urban renewal of the 1970s. Huge assets were lost during the decline and subsequent urban renewal, at huge financial and social cost – including displaced persons and treasured historic buildings. In the early 21<sup>st</sup> century, Helena was still struggling to regain the vibrancy of a downtown that existed prior to the 1950s. The Downtown Plan that was developed a few years ago appears to be making a difference.

8. Shelter Does NOT Meet Approval Criteria

The proposed shelter should not be approved because there is no credible evidence to indicate that it will not adversely affect public safety (and therefore does not meet the criteria of Section 11-3-4 of Helena Zoning Ordinance for a conditional use permit):

- A. The proposed shelter will adversely impact public health, safety, or general welfare. This shelter will increase the number of persons with violent and addictive behaviors on city streets, at a minimum for some portion of each day. Persons who are noticeably intoxicated or worse, with sometimes aggressive behaviors to passersby are not in the best interest of the general welfare.
- B. The proposed shelter will adversely impact and impair the peaceful use of existing property or improvements in the vicinity. The "low barrier" population is already impacting the peaceful use of existing property. If a 26-bed facility is built with no particular indoor place for the women who shelter there to go during the day, they are likely to join others outdoors. In addition, there will be others who come to Helena for the shelter but who may be unable to get into the shelter because it is at capacity and they will join those in the streets.

Regarding other legal criteria for approving the shelter, I believe it is a stretch to think that the proposed shelter would meet the requirement for compliance with the Helena Downtown Neighborhood Plan. The intent of the plan is to revitalize downtown, and to do that one does not knowingly decrease the safety of persons in downtown.

In fact, it would be difficult to see how any proposed similar shelter would meet the intent of a neighborhood plan anywhere in Helena if safety was potentially jeopardized.

#### 9. This is an Issue for the Entire City, not Just Downtown – We need a Comprehensive Plan Now

Consequently, if we as citizens of Helena are serious about addressing the unsheltered population, and I believe we are, we need to tackle this issue city-wide. We need to spread the responsibility to more locations in the city. If we do not, this issue is forced on downtown, despite expressed public opinion by business owners, property owners, and residents of downtown and nearby areas. If we do not as a city, plan for shelter and services for unsheltered individuals in various locations throughout town, we are no better than the cities that have punted their “problem populations” to other towns. This has been done in the past (and may still be occurring) by simply refusing to provide adequate services in their town, or worse, by giving them a bus ticket out of town. Let’s not let Helena start acting like that within its own city limits. This is a caring place and it’s clear we are already working to help people here who are recent arrivals.

We need a comprehensive plan for the spectrum of unsheltered individuals that ensures that downtown and nearby areas are not the ONLY place for shelter and services.

We need to continue building a great downtown and a great city. The downtown is the heart of any city. If it begins to deteriorate, we will lose huge investments in infrastructure and tax base as well. Tax revenue losses from the downtown core mean that other areas of the city have to make up the difference or the city will need to cut services. Let’s not re-create the issues that resulted in the exodus of the core of our city in the mid-20<sup>th</sup> century.

I will be more inclined to support any proposed shelter if we have a city-wide plan in place that spreads the responsibility for this issue across the city rather than leaving it almost exclusively to the downtown and surrounding area.

#### 10. Temporary One-Season Shelter

I would support the emergency shelter for this season only, with that temporary time frame included as a condition of the permit. Hopefully before we have another winter season, the city can have a meaningful city-wide plan such as I propose in this letter. Then the city can reassess a longer time frame for this shelter within the context of the plan.

There are many organizations in downtown generously serving the unhoused. God's Love has graciously carried the load and the Budget Inn across the street takes overflow. I have heard that the Helena Indian Alliance is considering turning their former building, two doors south of God's Love, into a shelter. I wonder if having two shelters, perhaps three, within a quarter mile of each other would irreparably alter downtown.

I would like to help our unhoused neighbors but feel protective of our downtown which is currently inundated with camps.

Safety is a concern. As a resident of Helena, I have a mental map in my mind of places to avoid. Including parks, tunnels, parking lots, parking garages, the back of Golden Girls, the back of the Holter Museum, the back of the Iron Front and more. Tourist and visitors are likely to stumble upon these places as they explore our historic downtown.

I fear that a concentration of shelters has the potential to **increase** the number of street camps, as many folks choose to set up camp close to a such facilities and may prefer not to sleep there. Certainly, our homeless problem needs to be addressed. Should downtown carry the burden exclusively? At what cost to our downtown, its businesses, tourism, and local residences?



Helena Community Members:

My name is Meg White. I have been attending the emergency housing task force meeting since August of 2023. I live at 1310 Oro Fino Gulch, one eighth of a mile from where the homeless tent city resided April to October of this year.

I do NOT support changing the zoning regulations or opening a women's shelter as it is being pursued by Good Samaritan Ministries.

I can see that there is a HUGE need to address the homelessness situation in our beautiful city, however I don't believe that opening a low barrier shelter here or anywhere for that matter is the answer to this complicated issue. This shelter will not require women to be sober, compliant with mental health or addiction treatment plans, nor will they require women to participate in programs to receive services and housing support.

I don't think in good consciousness, that we can continue to put families, business owners and patrons' needs and safety aside. Especially after having the experiences that my family has had these past 7 months and observing what is currently happening in the downtown area daily. Drugs, addiction, mental illness, and crime are all a part of the cycle of homelessness. Until these issues are dealt with, until we require the unhoused to actively participate in whatever those solutions look like, nothing will change. If we are willing to house the unhoused without any requirements, the cycle will go on. I believe that we have to begin to do things differently if we are going to see different results.

Family friends of ours were in Helena over the Thanksgiving break and were excited to attend the Parade of Lights downtown. They have a 7 and 8 year old. Their very first experience of Downtown Helena was of an unhoused woman screaming at another unhoused woman, threatening to kill her.

A week ago, I drove through downtown Helena on a Saturday with my daughter and a friend only to see 3 police cars surrounding the encampment on the corner near God's Love. We sat at the traffic light watching unhoused individuals approach officers, waving their arms, and hollering at them. I asked the young ladies in my car to pray with me. We prayed for safety for all and for guidance in this situation as we work to find solutions.

Just last Sunday my daughter and I were downtown again. This time we were parked in front of the post office on the corner of Placer and Last Chance Gulch. It was the middle of the afternoon. We watched an unhoused woman walk out of the encampment, pass God's Love, pass Golden Girls, turn up the hill and walk into a doorway. She pulled her pants down, crouched in a doorway and relieved herself. We were in shock.

When we walk through downtown Helena we are constantly on alert, much like we were the past 7 months at our home. I can feel my daughter's hand tighten in mine as we walk past unhoused individuals. This summer, she ran into our home in tears, afraid, when she saw a flash light on the trail above us, certain that someone was meaning harm. She was unable to go out unattended to take care of her animals because we didn't know who was lurking around. We should not have to live this way because others are making choices to live the way they are.

People have said to me that if I just learned more about the unhoused, met them, spent time with them, that I wouldn't be afraid. I am not afraid of the unhoused as much as I am afraid of what their actions do to our community, the decay, trash, uncleanliness, the crime, drugs, addictions and mental illness all affect us negatively. If the things that you've heard from me today and the things that others are sharing don't convince you that what we're doing isn't working, I'd suggest that you spend some time downtown yourself.

I'm new to being involved in this whole issue. While we no longer have a homeless encampment just down the road from our home, I will not look the other way and pretend like we don't need to continue to be involved. I am trying to continue to steep myself in stories and search for solutions, that others have tried and are finding success with, because this community is our home and because the way that we have been doing things, just giving people a place to stay and handouts without any buy in on their part is not kind, it's not helping, it's not even humane. All it's doing is allowing the unhoused to stay in the circumstances that they are in now. Is it hard? Is it going to take our time and our resources? YES!! But would it be worth it? YES!!!

I will support a shelter that requires residents to work through addictions including treatment and support groups, to work with mental health facilities and counselors, a place where residents are held accountable for the decisions they make, where they are encouraged to take care of themselves and to learn what it's like to be a contributing member of the community, a mother, a sister, a friend. A place where they can receive help getting something comparable to a high school diploma, filling out resumes and finding jobs. A place where those more fortunate can donate their time and their resources to be mentors and positive role models. I will be the first to sign up for a shelter of this capacity, but I cannot endorse a shelter that does not address these issues.

Thank you for taking the time to listen. I hope that the future brings us all working side by side to change each other's lives for the better.
