- (0:05:03) Call to Order and Roll Call It was noted that a quorum was present with four of the five members in attendance.
- (0:05:43) Minutes Minutes from the August 8, 2023 meeting were approved.

Regular Items

Item 1 Staff Presentation and Questions for Staff

- (0:06:39) Michael Alvarez, Planner II, gave a presentation on the new proposed sign ordinance.
- (0:23:51) Ms. Anderson asked about the cost incurred for removal of signs. Mr. Alvarez clarified that this applies to signs that have been ordered to be removed and in the case that the city removes it, then the cost will go to the sign owner. Chair Harbage asked about temporary signs. Mr. Alvarez explained that through the process of working on this proposed ordinance, regulations on temporary signs were not replaced.
- (0:27:43) Ms. Anderson asked if signage was a condition of approval for occupancy of a building. Mr. Alvarez stated that the signs regulated by this ordinance are not required for occupancy. There was continued discussion about temporary signs and the broader definition of temporary signs was clarified.
- (0:30:02) Mr. Alvarez continued with his presentation and noted that staff recommendation is to table the recommendation until the November 14th meeting to allow time for public engagement. Chair Harbage asked for clarification on what would happen with the different actions available to the Commission. There was additional discussion on things that needed to be worked on before this was brought forward again for a vote on recommendation if they voted to table.
